Vice-chairman, Bedgood stated the next agenda item we will hear the report of the Public Works Interim Director, Mr. Earl Townsend. Mr. Townsend distributed reports to the Council to see the work that has been done on the roads and he asked if there was any questions for him. Councilman Chris Paige, asked Mr. Townsend, "Do you know anything concerning Payne Subdivision and the Culvert/Bridge that was fixed on Miller Drive, Do you know about when the overlay will begin?" Mr. Townsend, replied, "I was there when the culvert was installed, but I don't know about when any road work will begin, Mr. Nowlin, would have to answer that because he works closely with the Parish Engineer."

Parish President went over talking about when they were approved and then re-approved, but they are approved now, Payne Subdivision and Coco Bed Road. For Coco Bed Road FP&C reviewed the plans and specifications the review notice included a list of items to be clarified or revised for final approval. The Parish will address all items and resubmit the documents to FP&C. Parish President stated, "We're continuing on with the Engineering, we know eventually we're going to get in re-approved." Councilman, Paige, wanted to know if the work that was done on the culvert, was that money taken from the \$200,000. Parish President, replied, "No, we actually did that in house."

Vice-chairman Bedgood then recognizes Ms. Sharon Harris, OCS/Head Start Executive Director, she gave her reports in the Council's packets and wanted to know if they had any questions, comments or concerns on the reports. Ms. Harris did want to highlight that beginning with the Child Nutrition Program they will begin eating healthy they will not be able to serve any more flavor milk only one percent milk and cupcakes and cakes will not be allowed anymore to parties, so the centers are going to stop cupcakes and cakes at parties. This is not an allowed cost for Head Start and they are going to discontinue Parents bringing in cupcakes and cakes. They are trying to get the children to begin eating healthy. Ms. Harris, replied, "Many don't like this, but we must follow the "Regs" and be in compliance and will help everyone by doing this." Ms. Harris also mentioned she has included a Performance Information Report this gives data on all staff and children and this is required by the Federal Government. Councilman, Paige, wanted to know about enrollment. Ms. Harris, replied, "Enrollment is good." Martin Luther King is the only center that is lacking and they are only lacking 8 spots due to children getting accepted in public schools and by riding school buses. Ms. Harris also stated, "Ms. Debbie will be talking about this later in her report, but the Nutritious Department was approved for the food van, that was budgeted for last year." Councilman, Paige, stated, "I see you have Mrs. Metoyer, back there, you need to call her up to let her introduce herself and let us see who she really is and let everyone get to see her." Councilman, Bedgood wanted to ask Ms. Harris a question about Goldonna, he told Mrs. Metoyer to come on up to the podium, "Let's cut through the chase and tell me about Goldonna one way or the other, yes or no." Ms. Harris, replied, "Goldonna, I'm not going to say a yes or no, but we do know the Federal Government has funded us for 309 children, and we do know if we open up a center in Goldonna, we'll have to cut somewhere else, because we're fully enrolled and I can't tell you that, I know someone had came in last month and told you that we could have, but there are a lot of things that must be done and the first thing was the assessment, it doesn't look like it's going to happen this funded year, but we can include it in the next Grant

period." Parish President wanted to know exactly how

many responded to the survey that was given, and Ms. Harris, explained, "It was only 9 people to send the survey back to me and you have to also look at longevity how many children are going to be left there." And Councilman Bedgood discussed that he had about 26 last year and a lot of them started to school this year, so they have dropped. Councilman Paige, with the commitment from all parties it just may happen, for next year to get a center in Goldonna, after they see all parties are pushing in the right direction for it and he hopes in the future we can build a new Head Start Facility to show the children we really do care.

Mrs. Chriscella Metoyer introduced herself as the Interim Head Start Director. She gave a brief summary of her work experience and Education background. She's in the process in getting the kids where they need to be and working on the teachers morale, and working on CLASS scores , they dropped a little last year, so everything is fixable, with teacher support and lots of training. Mrs. Metoyer said they're off to a good start and hope she can stay to get the program where it needs to be.

Vice-chairman, Bedgood, then recognizes Parish Treasurer Debbie Miley she explained that the Head Start Food Van was approved finally and the money came out of last funding year, and not this year's Grant. Miley also reported that she sent all the reports in the Council packages for Head Start, Credit Card transactions, all checked written, and inmate report, and a print out of all vendors. Ms. Miley asked if there was any questions about anything she sent or anything needed to be explained. There wasn't any questions.

Vice-Chairman Bedgood then recognizes Parish President, Parish President wanted to go over a couple of items on his report.

The engineering of the improvements to the streets of Payne Subdivision is in progress.

Hurricane Harvey Recovery:

A. On September 6, 2017, the Parish met with representatives of GOHSEP to begin the process of identifying the damages to Parish infrastructure as a result of Hurricane Harvey.

B. On September 18, 2017, the Parish met with representatives of GOHSEP and FEMA to further define the Preliminary Damage Assessment (PDA). As a result of the work done by Public Works, the repairs are estimated to cost approximately \$600,000. This figure will probably increase as a number of the roads are still under water and the extent of the damages on them cannot be determined at this time. In addition, the Parish has expended approximately \$40,000 in the

completion of emergency repairs made to restore transportation prior to the permanent repairs.
